**ORDER
RE-ISSUING SUBPOENA**

By request dated November 10, 2025, the Respondent, Duquesne Light Company, made an application for subpoena of Samantha Old (Ms. Old), 1322 Complete Street, Pittsburgh PA 15212.

Respondent avers Ms. Old is the spouse of Complainant, Christopher Old (Complainant or Mr. Old), and called Respondent to establish electric service for an account in Mr. Old's name at 3122 Shadeland Avenue, Pittsburgh, PA 15212, an account Mr. Old now claims was opened fraudulently. Respondent avers Ms. Old's testimony is required in order to determine whether Mr. Old's account was in fact opened fraudulently.

The application was served on both Ms. Old and Mr. Old, and no objections were filed.

The application was granted and the subpoena was issued by Order entered December 18, 2025. The date listed on the issued subpoena was January 20, 2026.

Subsequently, I had a scheduling conflict for the original hearing date of January 20, 2026, and contacted the parties for dates to reschedule the hearing. The parties agreed to reschedule the in-person hearing for February 4, 2026.

On January 6, 2026, the Commission issued a Notice, cancelling the hearing on January 20, 2026, and rescheduling it for February 4, 2026.
