1. Service Area

Our service area originates from points in Allegheny, Armstrong, Beaver, Bedford, Blair, Butler, Cambria, Center, Clarion, Clearfield, Crawford, Elk, Erie, Fayette, Huntingdon, Indiana, Jefferson, Lawrence, McKean, Mercer, Somerset, Venango, Washington, and Westmoreland Counties to points in Pennsylvania, and return.

The proposed service area is supported by existing and developing relationships with healthcare facilities, including but not limited to Penn Highlands Healthcare, Allegheny Health Network, Independence and UPMC Hospitals, which operate facilities within the above-listed counties. Service will be provided on an advance-reservation basis and will be limited to a scope that can be supported by the applicant's available vehicles, drivers, and financial resources. As demand increases and additional resources are obtained, the applicant may seek to expand authority through separate application.

2. Driver Qualification & Monitoring Policies

The applicant has adopted written driver qualification and monitoring policies in compliance with 52 Pa. Code §§ 29.503, 29.504, and 29.505.

Driver Age (§29.503): All drivers must be at least 21 years of age. Proof of age and identity is verified through a valid Pennsylvania driver's license and retained in each driver qualification file.

Driver History and Record Retention (§29.504): Prior to being authorized to operate, the applicant obtains a current PennDOT driver record for each driver. Driver records are reviewed annually. Copies are retained in each driver's qualification file for the duration of employment and for at least three (3) years thereafter.

Criminal History (§29.505): All drivers are required to undergo a Pennsylvania State Police PATCH criminal background check and IdentGO fingerprint-based background check prior to hire. Background checks are repeated every two (2) years. Results are retained in each driver qualification file.

The applicant maintains a separate driver qualification file for each driver containing license information, background checks, training records, and compliance documentation.

3. Vehicles

- a. Vehicles will be paid in full in cash at the time of purchase.
- b. Sport utility vehicles or station wagons such as Ford Police Interceptor Utility, Ford Explorer, or similar vehicles suitable for non-emergency mental and behavioral health passenger transportation.
- c. The applicant currently owns one (1) vehicle and intends to acquire a second vehicle prior to commencing operations.

4. Insurance

Annual cost for commercial paratransit coverage is approximately \$16,424.00 for two (2) vehicles and two (2) drivers.

Coverage includes Liability \$1,000,000 combined single limit; Underinsured Motorist Bodily Injury (non-stacked) \$300,000 combined single limit; Uninsured Motorist Bodily Injury (non-stacked) \$300,000 combined single limit; First Party Medical Benefits \$25,000 per person/per accident; First Party Wage Loss \$10,000; Comprehensive deductible \$500; Collision deductible \$1,000.

The applicant intends to pay insurance premiums on a monthly installment basis from existing company funds.

5. Financial Information

The attached Statement of Financial Position reflects assets held by SecuRIDE Transportation LLC only. The \$6,700 motor vehicle equipment asset represents the cash purchase of a company-owned vehicle. Member capital in the amount of \$50,000 represents initial owner contribution to the company.

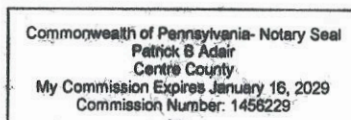


