TeamTig Towing & Recovery, LLC, a Pennsylvania limited liability company.

I. Formation of Company

The company was formed under the laws of the State of PA on 7/25/25.

II. Members

The following individuals are the initial members of the company.

. Tyler James Glunt

III. Purpose of the Company

The purpose of the Company shall be a towing and recovery business along with providing repossessions.

IV. Capital Contributions

Each member's initial capital contribution to the Company is as follows:

. Tyler James Glunt, with a capital contribution of 100%

V. Allocation of Profits and Losses

Profits and losses of the Company shall be allocated among the members in proportion to their respective capital contributions.

VI. Management and Decision-Making

A. Management

The Company shall be managed by its members collectively. Decisions relating to the Company's ordinary course of business shall be made by unanimous consent of the members.

B. Major Decisions

Major Decisions, including but not limited to changes to the Company's purpose, admission of new members, dissolution of the Company, and amendments to this Agreement, shall require the consent of 100% of the members.

VII. Meetings

Regular meetings of the members shall be held monthly, and special meetings may be called by any member with 15 days written notice.

VIII. Withdrawal of Members

Any member may withdraw from the Company by providing 30 day's written notice to other members.

IX. Dissolution

The Company shall be dissolved upon the occurrence of any of the following events:

- . Unanimous agreement of members
- . Bankruptcy or insolvency of the Company
- . Judicial determination that it is not reasonably practicable to carry on the business

X. Distribution of Assets

Upon distribution, the Company's assets shall be distributed among the members in proportion to their respective capital contributions.

XI. Amendments

This Agreement may be amended with the unanimous consent of the members.

XII. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of PA.




