- 2. I respectfully request reconsideration because the financial record before the Commission did not fully reflect our current and planned financial capacity.**
- 3. Second Season Transit LLC has secured proof of additional financial resources to support safe, efficient, and continuous operations. These resources include increased available cash in the business' account and funding dedicated specifically to insurance, vehicle maintenance, and operating expenses.**
- 4. The applicant acknowledges the Commission's concern regarding insurance costs. Proof of available funds and updated financial documentation are attached.**
- 5. Second Season Transit LLC also maintains ownership of a 2014 Ford Explorer and has allocated funds for maintenance, inspections, and compliance with all safety requirements.**

6. For these reasons, Second Season Transit LLC respectfully requests that the Commission reconsider its denial and allow the application for paratransit authority to proceed. Thank you.
