To Whom It May Concern:

The purpose of this Letter is to advise you that your application has been reviewed and approved by the Pennsylvania Public Utility Commission (Commission). Let it be noted that a member of HLSC LLC, Matthew Bold, brought to our attention a conviction in his record for a non-violent crime from the year 2012 for health care fraud stemming from his part in a scheme involving the transportation of patients with ambulances. However, Mr. Bold is no longer under court supervision, and while this conviction does give us cause for concern, it does not necessarily disqualify him. Therefore, this Commission has decided to approve the application, but please note that we do reserve the right to do a full inspection/audit associated with this entity.

Before you begin operations, you must file with the Commission all of the information listed in paragraphs (a) and (b) below. **You cannot operate under the approved motor carrier rights set forth in this Letter until all of the information listed below is filed with, and approved by, the Commission.** Once the information listed below is received and approved by the Commission, you will receive a Certificate of Public Convenience, with **PUC No. A-6428483** which authorizes you to begin operating under the motor carrier rights set forth in this Letter.

- a. An acceptable **Form E** filed by an insurance company which is evidence of bodily injury and property damage liability insurance. **Your insurance company must file a Form E with the exact name of the applicant as it appears on this Letter – HLSC LLC, t/a Healthlink Logistics The State MC A-6428483 must be listed to identify your account. All service types covered by this policy must be listed. Insurance filings are accepted online via Tyler Insurance Filings at www.tylerinsurancefilings.com.**

- b. Email **tariff draft** to: RA-PCTARIFFFILING@pa.gov. DO NOT E-File unapproved tariffs. Call (717) 214-7155 for assistance.

Upon issuance of a Certificate of Public Convenience you are granted the right to operate as follows:


To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the City and County of Philadelphia to points in Pennsylvania, and return.

FAILURE TO COMPLY WITH ANY PROVISION OF THIS LETTER WITHIN SIXTY (60) DAYS OF THE DATE OF THIS LETTER WILL RESULT IN THE DISMISSAL OF THE APPLICATION AND REQUIRE THE FILING OF A NEW APPLICATION AND FILING FEE.

You should become familiar with the requirements of 52 Pa. Code as applicable to the operation of a common carrier as authorized by this grant of authority. Any change in address must be reported to the Commission by filing a Change of Address Form. This form can be found on the Commission's website. Failure to comply with all applicable requirements may subject the carrier to penalties, including fines, suspension of operating rights or cancellation of authority. If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §5.44, file a petition with the Commission within twenty (20) days of the date of this Letter.
