RULES & REGULATIONS

1. Advance reservations are required and must be made at least two (2) days prior to service.
2. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
3. If any trip requires the vehicle and driver to remain at a destination overnight, or at any point en route to a destination overnight, the patron will be responsible for providing carrier's driver with accommodations at an overnight facility (motel, hotel) being utilized by the patron, and all meals required by the carrier's driver. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
4. **CONTRACT SERVICES**
Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

SCHEDULE OF RATES
(Per Person)

Standard Hours: Monday to Friday during school season From 6:30 AM to 4:30 PM

Flat Rate School Van: \$50.00 per person weekly

Reservations: To avail of our transportation services, the client will need to fill out a registration form and return it to us at least (2) two days before the intended start date to ensure the availability of our transportation service and streamline our operations effectively. The form can be submitted in person or via email

Cancellation Policy: In the event of service cancellation, the client will need to notify us at least (24) twenty-four hours in advance to avoid a \$10.00 charge for that week.

Waiting Time At Origin: After the first five (5) minutes of free time the passenger will be charged at the rate of \$5.00 for every five (5) minute increment, or any fraction thereof.

Waiting Time During Trip: If the driver is requested to wait for a customer at the destination or during a trip, there will be an additional waiting time charge of \$5.00 for every five (5) minute increment, or any fraction thereof.
