Request for Information

Questions for evaluation on a PUC Application require regulation compliant answers, they should be well thought out and complete, and must answer all parts of the questions asked. Please review Title 52 PA Code to ensure your answers meet that standard. Once you have addressed these basic requirements, we can then look further into other questions on your application.

- 1.) Contract carrier authority is defined as: “Charges by contract, Service contract to Transport employees/passengers for a specific company or companies filed with application.” Since you have specified no company or entity that you intend to contract with, please fully explain who will hold the contract which must be provided to the PUC to be granted authority. All contractors you intend to work with must be named in original application under question #10 for territory. Contractors are not interchangeable after being permitted, changes require a new application.
- 2.) You might have received the Provider Manual from the Department of Human Services. If so, are your intentions to limit your services to transportation for other Pennsylvania State Agencies? Are you also considering contracting with healthcare brokers like MTM, Modivcare, and / or AmericanLogistics?
- 3.) Are you considering providing service to the public (directly, without going through a contract)?
- 4.) Who arranges the trips, who pays you?

The purpose of the verified statement questions is to determine your ability to provide safe, efficient, and reasonable transportation. It is in your best interest to provide accurate, complete, and timely responses. Failure to do so is sufficient grounds to justify the denial of your application because you have failed to provide sufficient evidence of your fitness to operate. Be advised that additional corrections may not always be requested; therefore, prior to submitting

your responses, your consultation with an attorney or financial expert familiar with Commission regulated Motor Carrier related proceedings is highly encouraged.
