Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:



Request for Information

- 1.) Question number 3 of the Verified Statement of Applicant asks that you provide “evidence” of the two-years’ minimum experience with a licensed households goods carrier or the equivalent.

Please provide evidence that you worked for a Household Goods carrier. Paystubs or a letter of reference from your previous household goods employer evidencing the minimum of two years’ experience are acceptable.

- 2.) You failed to adequately answer all aspects of question number 5 of the Verified Statement of Applicant. Please review Title 52 Pa Code §29.501-509 Driver regulations to see what is required of motor carrier.

- a. Your system for conducting background checks

- i. How often will criminal background checks be conducted?

- ii. How will you maintain records (record retention) of the criminal background checks performed?

- b. Your system for conducting driver license/ driver history checks.

- i. How often will these checks be performed?

- ii. How will you maintain records (record retention) of such checks?

- c. Your system and policies for drug testing.
 - i. How often will drug and alcohol testing be performed?
 - ii. How will you maintain records (record retention) of such tests?

- 3.) Question number 6 of the Verified Statement of Applicant asks for the Year, Make, Model, Vehicle Identification Number (VIN) and the mileage of the vehicle you intend to use in your business.
 - a. Please provide that information below.

 - b. Should you plan to rent a truck, please explain how you will provide proof of liability insurance (Form E) and cargo insurance (Form H) as they are typically only provided for vehicles you own and register.

- 4.) Question number 7 of the Verified Statement of Applicant asks about your vehicle safety program. Please review title 67 Pa Code, Chapter 175.
 - a. How often will your drivers conduct safety checks?

 - b. Please provide a safety inspection checklist

- 5.) The Statement of Financial Position (Balance Sheet) shows \$40,000 under TOTAL LIABILITIES
 - a. Please correct your liabilities or remove the \$40,000 from the TOTAL LIABILITIES at the bottom of the page and resubmit the Balance Sheet.

 - b. Please include a bank statement for Lian's Moving LLC showing the full amount you have listed on your balance sheet. If you do not have an account for LIAN'S MOVING LLC, now is the time to do so. A personal bank account under your own name is not acceptable.

Failure to provide answers to all of the questions is sufficient grounds for the denial of your application so please get assistance or you may hire an attorney to aid you in the application process.
