1. As part of a reorganization, RWE Clean Energy Wholesale Services, Inc. decided to wind down the energy management part of its wholesale services business. This included its gas marketing function. RWE Clean Energy Wholesale Services, Inc. stopped all gas marketing activities in all states by February 28<sup>th</sup>, 2025. It has not engaged in any gas marketing activities since then and will continue to not engage in any gas marketing activities while this license abandonment is pending before the Commission.
2. RWE Clean Energy Wholesale Services, Inc. has not had any Pennsylvania customers since October 27<sup>th</sup>, 2024. It had one Pennsylvania customer, pursuant to an energy management agreement, who was notified on August 28<sup>th</sup>, 2024 that the energy management agreement it had entered into with RWE Clean Energy Wholesale Services would be terminated as of October 27<sup>th</sup>, 2024. A copy of the letter is enclosed.
3. All of the identified state agencies were sent notice of the proposed license abandonment by FedEx mail on December 18<sup>th</sup> 2025. Proof of delivery to each agency is also enclosed.
4. Notice of proposed license abandonment was also sent to Columbia Gas of Pennsylvania, Inc. on December 18<sup>th</sup>, 2025 by FedEx mail. Proof of delivery is attached.



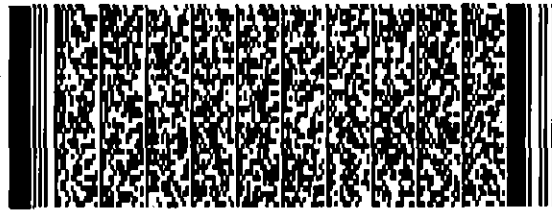

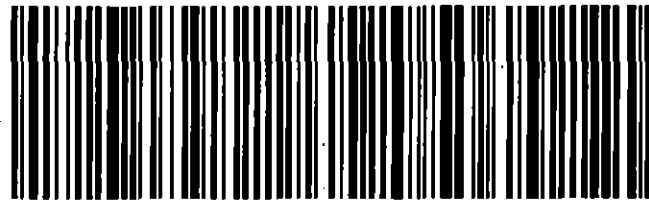
