Pursuant to the requirements set forth by the Pennsylvania Public Utility Commission (the "Commission"), this letter serves as formal notification of a change in the ownership structure and name of APN Starfirst, L.P., holder of an Electric Generation Supplier License.

Specifically, Axpo U.S. LLC, a Delaware limited liability company ("**Axpo U.S.**"), and Axpo Retail U.S. LLC, a Delaware limited liability company (individually, "**Axpo Retail U.S.**" and, collectively with Axpo U.S., "**Axpo**") have acquired APN Starfirst, L.P. This change in ownership occurred on December 12, 2025, and as a result, Axpo now holds 100% of the voting securities of APN Starfirst, L.P.

In addition, please be advised that as of December 31, 2025, APN Starfirst, L.P. has formally changed to APN Starfirst, LLC.

This notification is being provided in accordance with Title 52, Section 54.34 of the Pennsylvania Code which requires disclosure to the Commission of any material changes.




