PREHEARING ORDER # 5 AMENDING THE LITIGATION SCHEDULE

The Prehearing Order #4 issued on November 5, 2025, established the litigation schedule in the present matter as follows:

Public Input Hearings – Week of January 19, 2026 (one telephonic and one in-person)

Direct Testimony - Friday, February 20, 2026

Rebuttal Testimony - March 16, 2026

Surrebuttal testimony - April 6, 2026

Written Rejoinder - April 20, 2026

Evidentiary Hearings - Week of April 20, 2026 (four days, in-person, in Harrisburg)

Main Briefs - May 13, 2026

Reply Briefs - May 27, 2026

On February 6, 2026, the parties filed a Joint Motion to Amend the litigation schedule listed above. In their Joint Motion, the parties aver that a two-week extension of the present litigation schedule is necessary for them to review the engineer and tank inspection reports prior to the submission of the direct testimony. They argue that the information contained in the reports is relevant for their experts as part of their evaluation of the CLPWC system.

Upon careful consideration, I shall grant the Joint Motion and instruct counsel for CLPWC to submit a Witness Matrix by May 1, 2026.
