1. DRIVER POLICIES & PROCEDURES

(52 Pa. Code §§ 29.501–29.509)

a. Driver Hiring Standards (Age Restrictions – §29.503)

SNA Luxury Ride LLC currently operates as an owner-operator limousine service.

- The sole driver at this time is Nadeem Akram, Managing Member of SNA Luxury Ride LLC.
- Minimum driver age requirement is 21 years of age.
- No additional drivers are currently employed.

If the company elects to hire an additional driver in the future, such driver will be limited to immediate family members or long-term trusted associates with an established relationship, and all driver qualification requirements under Title 52 Pa. Code will be strictly followed prior to operation.

b. Criminal Background Checks (§29.505)

i. Method of Background Checks

Criminal background checks will be conducted using:

- Pennsylvania State Police PATCH system and/or
- FBI fingerprint-based background checks or approved third-party background screening services.

ii. Frequency

- Prior to operating as a driver
- At least once every twelve (12) months thereafter

iii. Disqualifying Offenses

Drivers will be disqualified for offenses including, but not limited to:

- Violent felonies
- DUI or substance-related driving offenses
- Sexual offenses
- Drug trafficking or distribution
- Any offense that poses a risk to passenger safety

iv. Record Retention

- Records will be maintained in secure digital and/or physical files
- Retained in accordance with PUC record-retention requirements

c. Driver Training Program

All drivers, including the owner-operator, will complete:

- Company safety orientation
 - Defensive driving principles
 - On-road vehicle familiarization and evaluation
 - Ongoing emphasis on passenger safety, professionalism, and regulatory compliance

d. Driver License & History Checks (§29.504)

i. Method

- Motor Vehicle Record (MVR) checks conducted through PennDOT

ii. Record Retention

- Records securely maintained and retained per PUC regulations

2. VEHICLE SAFETY PROGRAM

All drivers will complete pre-trip and post-trip inspections, including:

- Brakes, tires, lights, fluids
- Safety equipment
- Vehicle cleanliness and operational readiness

Any defects will be reported immediately and corrected prior to operation. Inspection records will be maintained.

3. COMMERCIAL INSURANCE

Commercial motor vehicle insurance quotes are enclosed, reflecting coverage compliant with Pennsylvania Public Utility Commission requirements, including minimum required liability limits.

4. REVISED STATEMENT OF FINANCIAL POSITION

A revised Statement of Financial Position is submitted in compliance with PUC instructions and reflects:

- Assets and liabilities held solely in the name of SNA Luxury Ride LLC
- Exact bank account balances (rounded to nearest dollar)
- No personal assets included


