

**PETITION OF  
SUNRISE ENERGY, LLC FOR LEAVE  
TO WITHDRAW FORMAL COMPLAINT**

NOW COMES Sunrise Energy, LLC (“Sunrise”), by and through its counsel, HMS Legal LLP, pursuant to 52 Pa. Code § 5.94(a), and hereby Petitions the Pennsylvania Public Utility Commission for Leave to Withdraw its Formal Complaint in the above-captioned matter. The Formal Complaint was filed with the Commission on August 11, 2025, and over the next several months the Parties engaged in discussions aimed at resolving this matter. That process ended without resolution. With litigation ensuing, on January 22, 2026, Sunrise filed a Motion for Sanctions, seeking an Order requiring FirstEnergy to produce certain discovery responses to which FirstEnergy has yet to provide answers, yet to which it never objected. FirstEnergy answered that Motion on January 27, 2026. By Notice dated February 4, 2026, the Parties were informed of a Prehearing Conference to be held on March 17, 2026 before the Honorable Administrative Law Judge Mark A. Hoyer.


Due to the passage of time, the relief requested in the Complaint will soon become moot if

the proceedings continue in this forum. Accordingly, because nothing has been resolved before the Commission, Sunrise desires to withdraw its Complaint, without prejudice, so that it can pursue other remedies as appropriate. Sunrise reserves the right to refile this Complaint at some future point, if necessary.

No party will be harmed by this withdrawal, and the Commission will be relieved of the need to expend any further resources. Sunrise, accordingly, requests that the Prehearing Conference currently scheduled for March 17, 2026 be canceled and that Sunrise's Complaint in the above-captioned matter be withdrawn without prejudice.

In the interests of conserving the resources of the Parties and the Commission, Sunrise respectfully requests to withdraw the above-captioned Complaint without prejudice.
