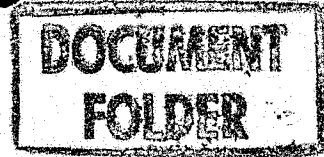

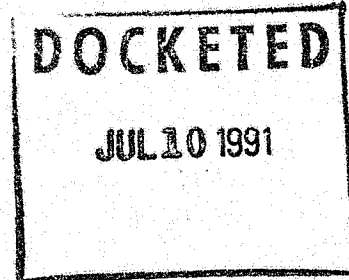

EMERGENCY ORDER

Pennsylvania Department of Transportation (PennDOT) is currently in the process of preparing final plans, under the above-captioned proceeding, for replacement of the bridge carrying Spring Mill Road (S.R. 0320) over and above the tracks of National Railroad Passenger Corporation (AAR 531 297 Y), adjacent to Villanova University, in Radnor Township, Delaware County. Construction of the project is expected to be completed in late 1992.

During the early morning hours of June 14, 1991, the superstructure of the subject bridge was struck by a passing vehicle resulting in extensive damage to the top chord of the structure's west truss. Radnor Township, in cooperation with PennDOT, took immediate action to temporarily barricade the bridge following the accident.

PennDOT avers that it is not feasible to repair the damaged truss and recommends that the crossing remain closed until the structure is replaced. PennDOT agrees to place permanent barricades at the crossing and to post an appropriate detour at its initial cost and expense.

After consideration of the information available at this time and in the interest of public safety, it is determined that the action taken by Radnor Township and PennDOT to close the bridge should be affirmed;  
THEREFORE,

IT IS ORDERED:

1. That the action taken by Radnor Township and Pennsylvania Department of Transportation to close the bridge carrying Spring Mill Road (S.R. 0320) over and above the tracks of National Railroad Passenger Corporation in Radnor Township, Delaware County to vehicular traffic be and is hereby affirmed.

2. That Pennsylvania Department of Transportation, at its initial cost and expense, immediately erect and maintain adequate barricades at appropriate locations at the subject bridge.

3. That Pennsylvania Department of Transportation, at its initial cost and expense, immediately furnish all material and do all work necessary to install appropriate signs at each adjacent public highway intersection, with the information "BRIDGE CLOSED AHEAD" shown thereon.

4. That Pennsylvania Department of Transportation, at its initial cost and expense, immediately furnish all material and do all work necessary to establish, mark and maintain a suitable detour route for all vehicles.

5. That Pennsylvania Department of Transportation notify the Pennsylvania Public Utility Commission in writing within five (5) days after it has complied with the requirements of this order.

6. That in all respects not inconsistent herewith, all previous orders of this Commission pertaining to the subject crossing shall remain in full force and effect.

7. That pursuant to 52 Pa. Code §3.3, a copy of this order be served upon all Commissioners, the Director of Operations, and the Secretary in addition to all parties of record and the Commissioner of the Pennsylvania State Police.
