On January 7, 2026, the Pennsylvania Public Utility Commission (Commission) received USA Energy Marketing Corp.'s Application for a Natural Gas Supplier (NGS) license. On January 29, 2026, the Commission served a Deficiency Secretarial Letter requesting missing or incomplete information. On February 10, 2026, USA Energy Marketing Corp. filed responses to the Deficiency Secretarial Letter. In order for us to complete our analysis of USA Energy Marketing Corp.'s NGS Application, the Commission's Energy Industry Group requires answers to the attached questions.

If your filing contains confidential material, you are required to either file by overnight delivery or submit to the Secretary's Share Point File system to ensure the timely filing of your submission. Filers should contact the Secretary's Bureau in advance to gain access to the Share Point File system. Make sure to reference the Docket Number listed above and mark the materials "CONFIDENTIAL" in bold or highlighted manner if any of the requested information is deemed to be of a confidential nature.


