Dear Mr. Fenicle:

On February 12, 2026, Compass Natural Gas Partner L.P.'s registration for renewal of the Act 127 Pennsylvania Pipeline Operator Annual Registration in the Commonwealth of Pennsylvania was accepted for filing with the Pennsylvania Public Utility Commission (Commission). The registration form was incomplete. In order for us to complete our analysis of your application, the Energy Industry Group requires answers to the attached questions.

Please be advised that you are directed to forward the requested information to the Commission within **20** days of receipt of this letter. Pipeline operators who fail to respond may be referred to the Commission's Bureau of Investigation and Enforcement and may be subject to civil penalties of up to \$10,000 a day that the violation persists. If Compass Natural Gas Partner L.P. no longer owns or operates equipment or facilities within the Commonwealth for the transportation of gas or hazardous liquids by pipeline or pipeline facility regulated under federal pipeline safety laws, it should notify the Commission along with necessary proof. Make sure to reference the Docket Number listed above when filing your response and mark the materials "CONFIDENTIAL" in bold or highlighted manner if any of the requested information is deemed to be of a confidential nature.

Data Requests

- 1) Reference Act 127 Registration-Reporting Year, Staff notes that the registrant identified “2026” as the year ending at the top of the Act 127 Registration submitted on February 12, 2026. Please confirm that the instant registration is for the year ending 2025, as registrations for the year ending 2026 are not due until March 31, 2027.
- 2) Reference Act 127 Registration-Section 1, Name of registrant-Staff notes that in the initial Act 127 Registration submitted on February 7, 2023, the registrant identified its name as “Compass Natural Gas Partner L.P.” (Partner was singular). Subsequent registration forms, however, were submitted under the name “Compass Natural Gas Partners L.P.” (Partners was plural).

Please clarify whether the discrepancy was the result of a clerical oversight at the time of the initial submission, or whether the company underwent a legal name change. If the latter, please provide the effective date of the name change and supporting documentation such as a certificate of amendment or similar filing evidencing the change.
