Dear Mr. Homsher:

Today, I received the Withdraw of Appearance document for the original attorney, Khadijah Scott, via an email from the new attorney for PECO, Margaret A. Morris.

On February 9, 2025, I emailed you and Judge Quimby regarding not receiving the Withdraw of Appearance from Ms. Scott.

I only became aware that Ms. Scott was no longer representing PECO in our case when I received an automatic response from her email account at PECO stating she was "no longer with PECO." I had emailed her a copy of my Exceptions per your requirements.

According to 52 Pa Code 1.24, Ms. Scott was supposed to file the Withdraw of Appearance and send me a copy. The documentation only arrived this morning. As I understand the code for attorneys in these matters, failure to properly serve the Withdraw of Appearance can result in disciplinary action. I believe she did not properly serve me in an appropriate time frame.

A simple google search on Ms. Scott / PECO resulted in several PUC cases where she gave her Withdraw of Appearance as far back as December of 2025: 12/19/25 Singletary vs PECO and 12/23/25 Yisrael vs PECO (both are attached). I don't know why I only received mine today. Maybe it has something to do with my email last week. Regardless, I think this proves that I was not served her documentation properly and therefore, she should be disciplined per 52 Pa Code 1.24 and any other codes that are appropriate.

I would appreciate you looking into this matter and letting me know the outcome.
