Dear Secretary Homsher:

On February 17, 2026, UGI Utilities, Inc. – Gas Division (UGI or Company) filed an Ex Parte Petition for Emergency Order of UGI Utilities, Inc. – Gas Division. In its Petition, UGI seeks to temporarily reduce the Company's Purchased Gas Adjustment Quarterly Adjustment Mechanism rate change cap from 25% to 10% for the March 1, 2026 quarterly C-factor adjustment. UGI requests that the Commission grant its Petition for Ex Parte Emergency Order and ratify it by the next Public Meeting date scheduled to occur on February 19, 2026.

The Bureau of Investigation and Enforcement (I&E) respectfully requests that the Commission deny this request and allow for interested parties to perform a full and complete review of UGI's Petition and the impact therefrom. I&E is concerned about the future impact on customer bills on a forward-looking basis and is concerned that the true impact of this proposal on future customer bills has not been fully vetted.

As such, I&E intends to file an Answer to the instant Petition within the 5-day timeframe allowed for in the Commission's regulations or as otherwise directed to by the Commission. 52 Pa. Code § 3.6.
