On February 12, 2026, PECO Energy Company (PECO) filed a Letter of Notification for approval to construct additional structures on the 220-84 230 kV Transmission Line, 220-85 230 kV Transmission Line, and 220-97 230 kV Transmission Line in Delaware County, Pennsylvania. In order for us to complete our analysis of the subject application, the Bureau of Technical Utility Services requires answers to the enclosed data requests. This information is necessary for completion of our review of the filing.
