NOTICE OF SUSPENSION OF PUC Truck OPERATING AUTHORITY
Effective 02/13/2026
Due to Cancellation of Cargo Insurance

As of 02/13/2026, your PUC operating authority is **SUSPENDED** due to your failure to maintain **evidence** of insurance on file with this Commission. Your insurer notified the Commission that it will cancel your insurance as of 02/13/2026. **You may not operate while under suspension.** Operating while under suspension is subject to prosecution, which may result in cancellation of your authority.

Your insurer must file appropriate evidence of insurance with the Commission. Appropriate evidence of insurance is a FORM E for bodily injury and property damage liability insurance, a FORM H for cargo liability insurance. This form must be filed with the PUC by the Insurance Company, **not by you.** Incomplete forms, incorrect forms and fax transmittals will NOT be accepted. A Form E or H may be filed online by the Insurance Company or your Agent via TYLER Insurance Filings at www.tylerinsurancefilings.com.

If your insurer does not file acceptable Form E or H with the Commission, appropriate action will be taken which may result in the cancellation of your operating authority.

If your Insurance Company or Agent timely files a Form E or H, you may resume operations.

You are to check your insurance status at the Commission online at its web site www.puc.pa.gov/search/utility-authority-search/. A utility search can then be completed by clicking "Add Additional Search Criteria" to search by other criteria. Once the search results populate, click on the utility code that corresponds to your authority. Note there are tabs you can click in order to view your utility info, authority, and insurance.

If you are no longer in business, please notify the Commission by submitting a cancellation form.
