I am sending this Petition for Reconsideration of the decision made February 11, 2026, determining that the proposed operations of MH Harvesting & Hauling LLC are PRIVATE TRANSPORTATION OF PROPERTY. I do not haul private – I am For Hire Only and the PUC authority is required for me to operate as a motor carrier in Pennsylvania.
2. Following are the steps taken to apply for PUC authority
 - a. I submitted an application for PUC authority on January 19, 2026
 - b. The application was received and posted on January 21, 2026
 - c. A Data request letter was issued January 26, 2026
 - d. I mailed my response on February 3, 2026
 - e. The letter was received by PUC SEC BUR on February 5, 2026 and posted on February 10, 2026
 - f. Denial for no jurisdiction was posted on February 11, 2026
 - g. I am solely for hire. I made the wrong selection on number 1 of the Request for Information page of the Data Request Letter. Because I am solely For Hire, I should have answered NO. I am including a corrected copy of the Data Request Letter.

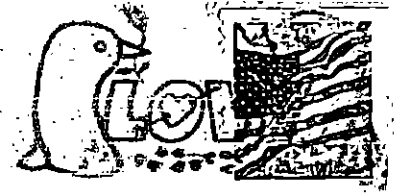
