

NOTICE OF COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified and the original **mailed to**:

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a civil penalty, the suspension or revocation of your operating authority, or other such remedy.
- C. You may elect not to contest this Complaint by paying the civil penalty requested in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a civil penalty and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the requested civil penalty set forth above.

COMPLAINT

The Pennsylvania Public Utility Commission (“Commission” or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement – Motor Carrier Division hereby represents as follows:

1. That JAMES E. RUBRIGHT JR, T/A OUTLAW TRUCKING & AUTO SALVAGE, LLC, Respondent, maintains its principal place of business at 325 Hill Street, Meyersdale, PA 15552.
2. That a certificate of public convenience issued by this Commission is required to transport as a motor common carrier, property, excluding household goods in use, between points in Pennsylvania for compensation. Based on review of records maintained by the Commission, Respondent has not applied for or ever received a certificate of public convenience granted by this Commission.
3. That on July 9, 2025, PUC Motor Carrier Enforcement Officer Jeremy Smith conducted an inspection of a 2025 International truck, bearing PA registration number ZYJ1383 and having vehicle identification number ending in the last 4 digits 9823, operated by Respondent. Officer Smith found respondent in violation of transporting property between points in the Commonwealth without a certificate of public convenience granted by this Commission and issued Respondent a Driver/Vehicle Compliance Report (“DVCR”) detailing the violation. A subsequent Warning Letter, docketed at Bp8#3056295 was issued on August 5, 2025, informing PUC authority must be obtained prior to transporting property between points in the Commonwealth for compensation and advised Respondent to cease and desist from further violation.
4. That on January 6, 2026, PUC Motor Carrier Enforcement Supervisor Ernest Smith conducted an inspection of a 1999 Chevrolet truck, bearing PA registration ZVD5489 and having vehicle identification number ending in the last 4 digits 2157, operated by the Brian M. Livengood. Supervisor Snyder found Respondent in violation of transporting property between points in the Commonwealth for compensation without a certificate of public convenience granted by this Commission, as Respondent was transporting two vehicles from Somerset County to Copart Salvage Auto Auctions, Ebensburg, Cambria County, for \$196.76. Respondent was issued a DVCR and in accordance with Pennsylvania’s Motor Carrier Safety Assistance Program, a commercial motor vehicle inspection report.
5. That Respondent, by providing transportation services by vehicle for compensation without obtaining/holding a certificate/authority from the Commission, has violated 66 Pa. C.S. §1101, 1102(a) and 3310(a). The penalty for this violation is \$1,000.00.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that:

1. JAMES E. RUBRIGHT, JR, T/A OUTLAW TRUCKING & AUTO SALVAGE LLC, be ordered to pay a civil penalty of one thousand dollars (\$1,000.00) for the violations set forth in this Complaint and order such other remedy as the Commission may deem to be appropriate.
2. Respondent be directed to cease and desist from transporting property between points in Pennsylvania for compensation until such time as the proper authority has been granted by the Commission.
3. If payment of the civil penalty is not made, the Bureau of Investigation and Enforcement requests that:
 - a. The Commission verify motor vehicle registrations to the Pennsylvania Department of Transportation for suspension or revocation, pursuant to 75 Pa. C.S. §1375; and
 - b. The matter be referred to the Pennsylvania Office of Attorney General for appropriate action.
