RULES & REGULATIONS

1. Advance reservations are required and must be made five (5) hours prior to service being rendered. Any reservation made less than five (5) hours before travel time will be charged an additional fee.
2. Rates begin when the vehicle leaves carrier's garage and terminate when the vehicle returns thereto.
3. A 20% Driver Gratuity will be assessed in addition to all other published rates and charges.
4. All tolls, parking fees and other out-of-pocket expenses shall be the responsibility of the customer and will be added onto carrier's charges.
5. Upon presentation of advertising coupon or special promotional offer, carrier will offer rates at a specified discount from the published Tariff Rates on dates authorized by the coupon or special promotional offer. Advertised coupon or promotion offer will be filed with the Public Utility Commission prior to publication/broadcast. Coupons will be published and promotional offers will be broadcast in one or all of the following: local newspapers, fliers and other printed media, and all forms of radio and television advertising media, including the internet.
6. A service charge will be added to trips to and from the Pittsburgh International Airport between the hours of midnight and 6:00 a.m.

SCHEDULE OF RATES

Reservations: Any Reservation made less than five (5) hours before travel time will be charged an additional \$25.00 fee.

Hourly Rates: Minimum charged will be for one (1) hour, or any fraction thereof. Additional time will be charged in thirty (30) minute/half hour increments, or any fraction thereof, at the following rates:

Luxury Sedan	\$ 95.00/hr.	\$ 45.00/hr.
SUV-6 Passenger	\$ 105.00/hr.	\$ 50.00/hr.
Sprinter Van	\$ 140.00/hr.	\$ 70.00/hr.
Airport Service Charge (See Rule 6)	\$ 15.00	

Gratuity/Tip: A minimum twenty percent (20%) gratuity/tip is assessed for transportation services of all vehicle types listed.

VEHICLE DESCRIPTIONS

Luxury Sedan: This vehicle is air conditioned, has a deluxe radio, leather interior and can seat 4 passengers.

SUV - 6 Passenger Limousine: This vehicle is air conditioned, has darkened windows, a partition, intercom, deluxe stereo and leather interior.

Sprinter Van: This vehicle is air conditioned with leather interior and is designed to hold approximately 11 passengers.
