Please be advised that the gathering pipeline in Clarion County, PA, previously operated by Northeast Natural Energy LLC, is now operated by NNE Midstream LLC. Both entities operate under the same corporate structure. After consulting with PA PUC earlier this year, we filed PHMSA form A requesting the name change. Previous Act 127 pipeline operator annual registration forms have been filed under Northeast Natural Energy LLC, Docket A-2023-3040986. The name change request approval is attached, along with the NNE Midstream LLC declaration of formation. Also, a new EIN number was assigned for NNE Midstream LLC.

I filed the 2025 pipeline operator annual registration form on February 25, 2026. However, I was informed that since a new EIN number was obtained for NNE Midstream LLC, a new docket number must be assigned. The pipeline registration form is attached with the docket number section left blank. Please let me know if you require additional information.
