

Dear Mr. Rich:

I am writing on behalf of Paging Network of Pittsburgh ("PageNet") in response to a June 1, 1992 letter from Robert F. Wilson regarding the Commission's annual report filing requirement and pursuant to a conversation with Commission staff.

PageNet was granted a Certificate of Public Convenience and Necessity to furnish one-way mobile radio-telephone service within certain areas of Pennsylvania on June 20, 1991 (Docket A.330013). To date, PageNet has not completed construction of the facilities from which it is authorized to provide service, and anticipates such completion in July, 1992. As such, PageNet did not provide service in Pennsylvania at any time during 1991 and therefore, filed no annual report.

PageNet is cognizant of the Commission's annual report requirement and will timely file such a report once it initiates service in Pennsylvania.


