BY THE COMMISSION:


On August 29, 1991, Commonwealth Telephone Company (Commonwealth) filed an Application for a Certificate of Public Convenience pursuant to 66 Pa. C.S. §1102(a)(3), in connection with the transfer of Commonwealth Telephone Company's present corporate headquarters to SRHC, Inc., an Affiliated Interest wholly-owned by C-TEC Corporation.

Commonwealth states that this transfer of real property, at full appraised value, represents optimal use of the corporate headquarters facilities to both Commonwealth Telephone Company and SRHC, Inc.

After investigation and analysis of, it does not appear that the proposed transfer is unlawful, unjust, unreasonable, or contrary to the public interest. This does not constitute a determination of the lawfulness and reasonableness of the filing. Rather, this is a determination that suspension or further investigation of the tariff filing is not warranted at this time; **THEREFORE,**

IT IS ORDERED: That Application of Commonwealth Telephone Company for approval to transfer to an Affiliated Interest property used and useful in the public service be, and hereby is, approved, effective November 1, 1991.
