Your Honors:

On behalf of the Solar Energy Industries Association and the Coalition for Community Solar Access (the “Joint Solar Advocates”), we are writing to advise you and the parties that the Joint Solar Advocates will not be filing any testimony in response to the previously filed rejoinder testimony of PPL Electric witness Andrew Castanaro in light of the settlement in principle that has been negotiated between PPL Electric and the Joint Solar Advocates, as described by Mr. Ryan in this email to you on Friday, February 27th.

Although settlement negotiations on all the issues in the case continue, PPL Electric noted late last week that it had reached a non-unanimous settlement on the Maximum Registered Peak Load (“MRPL”) issue with the Joint Solar Advocates and Dimension. To date, the only parties that have advised they oppose that non-unanimous settlement remain CGC and PDMP. Therefore, regardless of whether the MRPL settlement is a part of a full settlement agreement or a stand-alone partial settlement agreement, both the Joint Solar Advocates and PPL Electric expect that CGC and PDMP will oppose the MRPL-related provisions of the settlement.

As such, the Joint Solar Advocates and PPL Electric plan to file a Joint Stipulation in Settlement on the MRPL issue this week that sets forth the terms of PPL Electric’s MRPL proposal as modified by the non-unanimous settlement.

If the MRPL settlement is not part of a broader settlement petition in the case, both PPL Electric and the Joint Solar Advocates respectfully request that Statements in Support of or Opposition to the Joint Stipulation be filed by the Reply Brief due date previously established in the proceeding.

Please let us know if this approach is acceptable to Your Honors.
