continue to call West Penn to get

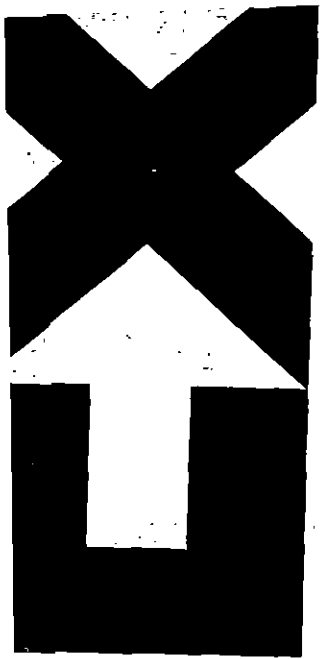
