Dear Secretary Homsher,

The purpose of this letter is to notify the Pennsylvania Public Utility Commission (“Commission”) that Rhythm Retail, LLC (“Rhythm”) intends to abandon its electric generation supplier (“EGS”) license approved by Commission Order entered November 9, 2023, at the above-referenced docket. The following information is being provided in support of the request to abandon Rhythm’s EGS license:

- Rhythm has never actively marketed its services in Pennsylvania and has never had any customers in Pennsylvania.
- Enclosed as Exhibit No. 1 is a Statement of Account from the Pennsylvania Department of Revenue dated February 26, 2026 showing that Rhythm has no unpaid tax obligations.
- Rhythm has never had any formal or informal complaints filed against it in Pennsylvania.
- Rhythm is currently complaint with the Commission’s required annual fees and supplemental annual fees. Exhibit No. 2 provides an email from the Commission’s Bureau of Administration dated February 19, 2026 evidencing Rhythm’s compliance.
- Rhythm has not completed the process of becoming a member of PJM Interconnection, LLC (“PJM”) and therefore has no outstanding obligations to PJM.


