1. This application is required to request a Certificate of Public Convenience to operate as a commercial carrier of people, when providing transportation on a nonexclusive, advance reservation basis. Service includes, but not restricted to:

- Transportation of people whose personal convictions prevent them from owning or operating motor vehicles.
- Transportation of people to correctional facilities for visitation.
- Transportation of people in wheelchair and stretcher vans.

****Important Note: Paratransit carriers may not render service to or from airports.***

2. Upon approval of the application, you will be notified that prior to providing service in Pennsylvania you must submit evidence of insurance to the Public Utility Commission. **Your permanent evidence of insurance will be a Form E for bodily injury and property damage insurance.** This form is mailed to the Commission directly from the home office of your insurance carrier. The name and address on your Form E must **exactly** match the name and address you have provided on your application. Your insurance company must subscribe to the NIC Insurance Filing website at www.nicinsurancefilings.com . You will request the insurance company (not the agent) to file the required insurance forms electronically through NIC. Mailed insurance forms are no longer acceptable. The minimum limits of insurance are as follows:

To provide non-emergency paratransit transportation within the City of Philadelphia, including Center City, University City, North and Northeast Philadelphia, and surrounding communities.

Service includes transporting persons whose circumstances prevent them from operating motor vehicles, transportation to correctional facilities within Pennsylvania, and wheelchair-accessible transportation between points within the proposed service area.

Examples:

- *To transport people whose personal convictions prevent them from owning or operating motor vehicles from points in Lancaster County to points in PA, and return.*
- *To transport people from the city and county of Philadelphia to correctional facilities in PA, and return.*

I have professional experience in public service operations and field coordination, including safety compliance, equipment oversight, scheduling, and operational management. Through this experience, I have developed strong organizational and supervisory skills and a thorough understanding of safety procedures and regulatory compliance.

I am familiar with the responsibilities involved in providing safe, reliable, and timely passenger transportation and understand the service needs of elderly, disabled, and mobility-limited individuals. I am committed to maintaining high standards of safety, customer service, and operational efficiency.

My background, training, and experience have prepared me to manage vehicles, supervise drivers, maintain compliance with applicable regulations, and ensure dependable transportation services to the public.

4. Describe your facilities, record maintenance plan and your communication network. I will operate from my principal place of business, where scheduling, dispatch, and recordkeeping will be managed using a computer, telephone, and secure digital filing system. Vehicles will be stored at a secure off-street location when not in service.

All required PUC records, including driver files, maintenance records, trip logs, and insurance documentation, will be maintained electronically with backup storage.

Customer requests will be received by telephone and scheduled in advance. Drivers will be dispatched by mobile phone, and continuous communication will be maintained to monitor trip status and ensure safe and timely service.

I intend to operate initially with one to two drivers, which is appropriate for the size of the service area and anticipated demand.

Drivers must possess a valid driver's license, maintain a safe driving record, and demonstrate the ability to assist elderly and mobility-limited passengers. Criminal background checks and driver record reviews will be conducted prior to hiring and periodically thereafter.

Drivers will receive training in passenger assistance, wheelchair securement, defensive driving, and emergency procedures. A zero-tolerance policy regarding alcohol and drug use will be enforced.
