**Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective April 13<sup>th</sup>, 2026, for U-Relax Moving Co. (PA PUC Certificate #A-8925359) in Jacobus PA.**

The attached pages are 747<sup>th</sup> Revised Page 2, 2<sup>nd</sup> Revised Page 2-G, 6<sup>th</sup> Revised Page 7-A, 2<sup>nd</sup> Revised Page 105-B-7, 2<sup>nd</sup> Revised Page 106-B-8, and Original Page 105-B-9.

This filing is a request for a **REDUCTION** in Non-Peak Season local hourly rates (shipments transported forty (40) miles or less) on Sundays & Holidays, Driver & Supervisor Monday-Thursday and Fridays & Saturdays, and an **INCREASE** for Vehicle & Additional Men Monday-Thursday and Fridays & Saturdays, the **ADDITION** of Peak Season Rates for local moves, the **ADDITION** of an administration fee to be applied on all moves (shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles), a **CHANGE** in the application of travel time charges for local moves, and a **REDUCTION** in specific container charges as noted on Page 105-B-9.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 3 hours at rates named in Columns 1 and 2. Fridays and Saturdays (any hour) and Monday-Thursday (6:01PM to 5:59AM): 3 hours at rates named in Columns 1 and 4. Monday-Thursday (6:00AM to 6:00PM): 3 hours at rates named in Columns 1 and 3.

NOTE 5 - When move runs beyond eight (8) hours on the same day, the Sundays & Holidays rates in Column 2 will apply for all work performed after eight (8) hours.

▲ NOTE 6 - Carrier will assess an administration fee of **\$25.00** on all shipments. This fee will apply to shipments transported forty (40) miles or less and shipments transported in excess of forty (40) miles.

▲ NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined time according to Google Maps, MapQuest, TruckRouter or a similar computer program designed to calculate mileage & travel time between points from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal under normal traffic conditions: Minimum travel charge is 1/2 hour and travel charge will be assessed in 15 minutes increments thereafter.
