ORDER
DIRECTING NEXTERA ENERGY TRANSMISSION MIDATLANTIC, INC.
TO PUBLISH NOTICE OF PREHEARING CONFERENCE

On March 3, 2026, NextEra Energy Transmission MidAtlantic, Inc., (NEET MA or Applicant) filed an Application pursuant to Chapter 57, Subchapter G of the Commission’s regulations. 52 Pa. Code §§57.71-57.77. The Application requests that the Commission approve the siting and construction of a new 500 kilovolt (kV) transmission line associated with the MidAtlantic Resiliency Link Project (MARL Project) in Dunkard Township in Greene County, and Springhill Township in Fayette County, Pennsylvania.

The MARL Project involves the construction of a new approximately 107.5-mile 500-kV transmission line across Maryland, Pennsylvania, West Virginia, and Virginia, as well as a new Woodside 500/138 kV Substation in Virginia. The Pennsylvania portion of the MARL Project will extend from the existing FirstEnergy Corp. 502 Junction Substation in Greene County, Pennsylvania for approximately 2.7 miles to the West Virginia border, extend through West Virginia for 3.1 miles, and then re-enter Pennsylvania in Greene County, and traverse through Greene and Fayette Counties for 8.0 miles, and then proceed back into West Virginia (the Pennsylvania Portions). NEET MA seeks approval of the siting and construction of the approximately 10.7 miles long Pennsylvania Portions of the MARL Project.

NEET MA seeks an in-service date for the Pennsylvania Portions of December 2029 or earlier. NEET MA requests that the Commission issue a final order in this matter no later than the latest March 2027 public meeting date.

A telephonic Prehearing Conference has been scheduled in this proceeding for **May 6, 2026**, beginning at **10:00 a.m.** Formal protests and petitions to intervene must be filed in accordance with 52 Pa. Code (relating to public utilities) on or before **Friday, May 1, 2026**.

This Order directs NEET MA to publish notice of the Prehearing Conference and the May 1, 2026 deadline for the filing of protests and petitions to intervene in newspapers of general circulation in the areas included in this Application once per week for two consecutive weeks prior to the date of the Prehearing Conference, consistent with the Pennsylvania Public Utility Commission's regulations and the ordering paragraphs below. The first notices shall be published **by March 21, 2026**, and the second notices shall be published no later than **7 days after the first notices** are published.

Proof of publication shall be filed with the Secretary with a copy provided to the undersigned presiding officer.

Accordingly, the following Order will be entered.

THEREFORE,

IT IS ORDRED:

1. That NextEra Energy Transmission MidAtlantic, Inc., shall publish notices of the Prehearing Conference and the May 1, 2026 deadline for the filing of protests and petitions to intervene in newspapers of general circulation in the areas included in this Application once per week for two consecutive weeks prior to the date of the Prehearing Conference. The first notices in each publication shall be published by March 21, 2026, and the

second notices shall be published not later than 7 days after the first notice is published. The notices shall be published in the newspapers of general circulation in the areas where the proposed transmission lines exist, are to be constructed, and/or are to be rebuilt, including Dunkard Township in Greene County, Pennsylvania, and Springhill Township in Fayette County, Pennsylvania.

2. That said notices shall also include the address and electronic addresses to apprise the public regarding how and where protests and petitions to intervene may be filed and where to provide NextEra Energy Transmission MidAtlantic, Inc., with a copy of protests and petitions to intervene in this proceeding.

3. That said notices shall also contain a brief description of the proposed HV line, its location, a statement of the date, time and place of the Prehearing Conference and of its purpose and a statement as to where and when a copy of the Application is available for public examination.

4. That NextEra Energy Transmission MidAtlantic, Inc., shall file proofs of publication with the Secretary of the Pennsylvania Public Utility Commission and serve a copy on the presiding officer, within two weeks of publication.
