
This filing is a request for an **INCREASE** in local hourly rates (shipments transported forty (40) miles or less) for the Vehicle on Saturdays, Sundays & Holidays and a **REDUCTION** in the local hourly rates for the Driver, Additional Men & Supervisor on Saturdays, Sundays & Holidays; an **INCREASE** in the local hourly rates other than Saturdays, Sunday & Holidays; the **ADDITION** of a Full-Value Replacement rate for permanent storage; an **INCREASE** in the overnight holding fee; and an **INCREASE** in rates for containers and packing & unpacking labor.

The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

The Issue Date for these changes in Tristate 54 is March 13th, 2026, with an Effective Date of April 13th, 2026.

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes 1 to 8 below - The transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE shown in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2 and 3.

Hourly Rates apply only from time of arrival of vehicles and men at the first point of origin (continue during all loading, transportation from the first point of origin to the final destination and unloading) until completion of unloading and dismissal of vehicles and men by the shipper at the final destination.

Traveling Charge covers traveling to the first point of origin and traveling from final destination, irrespective of actual time involved in such traveling.

NOTE 1 - For shipments originating and destined to points authorized by carrier shown in Pennsylvania Operating Authority, the following travel charge will apply when distance:

- (a) Origin and destination within 10 air miles of carrier's terminal: one (1) hour charge at applicable rates.
- (b) Origin or destination is between 11 and 20 air miles of carrier's terminal: one and one-half (1 1/2) hours at the applicable rates.
- (c) Origin or destination is between 21 and 40 air miles of carrier's terminal: two (2) hours at the applicable rates.
- (d) When origin or destination is over 40 air miles of carrier's terminal, an additional one-half (1/2) hour charge at the applicable rates will apply for each additional 15 air miles.

NOTE 2 - Hourly Rates (Columns 2 and 3) are based on the day or days, as indicated, during which services are performed.

NOTE 3 - Hourly Rates (Columns 2 and 3) computed in half-hour periods; fractions of half hour considered one-half (1/2) hour.

NOTE 4 - Minimum Total Transportation Charge will be four hours at rates shown in Columns 2 and 3.

NOTE 5 - In addition to all other applicable charges, the following charges will be assessed for handling the bulky items below:

PIANO HANDLING FEE: Spinet - \$150.00 UPRIGHT - \$175.00 BABY GRAND/GRAND - \$250.00

GUN SAFES, LOCKERS OR CABINETS - \$225.00

NOTE 6 - FULL-VALUE REPLACEMENT PROTECTION

In lieu of rates in Tristate Tariff 50-T (Rule 38), the following rates will apply:

Full-Value Replacement Protection with \$0.00 deductible is \$0.80 per \$100.00 of the declared value

Full-Value Replacement Protection with \$250.00 deductible is \$0.70 per \$100.00 of the declared value

Full-Value Replacement Protection with \$500.00 deductible is \$0.60 per \$100.00 of the declared value

▲ Full-Value Replacement Protection for storage (all deductibles) is \$0.16 per \$100.00 per 30 days

The minimum coverage for Full-Value Replacement Protection is \$6.00 per pound or total value of \$10,000.00, whichever is greater.

◆ NOTE 7 - When requested by the shipper or required by the carrier to hold the shipment on the truck overnight in lieu of storage, the additional cost will be \$225.00 per vehicle per night.

NOTE 8 - Reads Moving Systems, Inc. will assess a booking commission up to a maximum 20% on the following shipment types booked by a foreign agent:

Shipments transported forty (40) miles or less: The commission will be an agreed upon percentage of the total hourly transportation charges.

Shipments transported in excess of forty (40) miles: The commission will be an agreed upon percentage of the total linehaul transportation charge.

The additional booking commission will not be levied on any shipment sold by and booked by Reads Moving Systems, Inc.
