Dear Secretary Homsher:

A Secretarial Letter dated January 14, 2026 (the "Secretarial Letter") in the above-referenced matters noted that Hidden Valley Utility Services, L.P., had not filed annual financial reports with the Pennsylvania Public Utility Commission ("Commission") since May 2022 for either the Water or Wastewater Divisions. It gave HVUS twenty days (*i.e.*, until February 3, 2026) to demonstrate compliance with its financial reporting obligations. Nevertheless, the Secretarial Letter referred this matter to the Bureau of Investigation and Enforcement for such further action as may be warranted.

This correspondence is filed pursuant to 52 Pa. Code § 5.591 (Reports of compliance) to advise the Commission that HVUS filed its 2022 financial reports for the Water and Wastewater Divisions on March 9, 2026. In addition, HVUS filed its 2023 and 2024 financial reports for the Water and Wastewater Divisions on March 10, 2026.
