

VERIFIED NOTICE OF ABANDONMENT

On December 18, 2025, the Pennsylvania Public Utility Commission issued an order granting the Application of National Fuel Gas Distribution Corporation (“NFG” or “Company”) for a Certificate of Public Convenience authorizing it to abandon natural gas service to one (1) residential premise in Pine Creek Township, Jefferson County, Pennsylvania. As of the date of filing of this Verified Notice of Abandonment, abandonment to the residential premise in question has been completed. Accordingly, pursuant to Ordering Paragraph Three (3) of the December 18, 2025 Order, NFG hereby submits this Verified Notice of Abandonment, with the following information as ordered:

(a) The completion date of the abandonment to the residential premise:

March 3, 2026

(b) A statement explaining how compliance with 49 C.F.R. § 192.727 relating to abandonment or deactivation of facilities were completed:

The Company-owned facilities providing gas to the Premises consisted of: (1) tap (off of the gathering system which was the source of gas to the Premises); (2) riser; and (3) Company-owned meter (“Meter”). Beyond the Meter was the Customer-owned houseline.

The Premises was physically disconnected from the gas supply as follows: (1) the tap was capped, thereby stopping the flow of gas from the gathering system; and (2) the riser and Company-owned meter were physically removed. With the Premises thereby physically disconnected from the gas supply, the customer-owned houseline was capped to complete the abandonment, all in compliance with 49 C.F.R. § 192.727(d).
