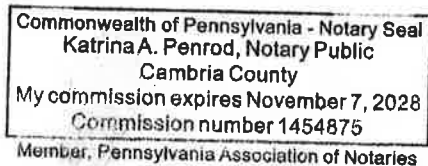

MEYERSDALE – Conemaugh Meyersdale Medical Center was honored Thurs-

day with a 2025 Performance Leadership Award from the Chartis Center for Rural Health. The hospital was recognized for excellence in patient per-

spective that places it among the top-performing rural hospitals in the nation. “This is a tremendous honor for our community hospital,”

Conemaugh Chief Operating Officer Jessica Svidergol-Peterman said in a release.

“Our hard-working, compassionate team consistently goes above and beyond for their patients. Their dedication to our mission of making communities healthier ensures that families in our rural region have access to high-quality care close to home – without the burden

of costly travel.”

This is the second year in which the Meyersdale hospital has earned the Chartis recognition. Awardees are determined through the Chartis Rural Hospital Performance Index, which is a “widely used, objective framework that benchmarks rural hospitals across key areas such as quality, outcomes and patient experience.”

Michael Topchick, Chartis’ executive director, described those categories as “cornerstones of health care delivery across rural America.”
