ORDER
HOLDING PROCEEDINGS IN ABEYANCE

This matter concerns a Petition filed by CSX Transportation, Inc. on January 29, 2015, with the Pennsylvania Public Utility Commission (“Commission”). In its Petition, CSX requested that maintenance responsibility for the bridge structure where Bort Road (T-270) crosses above CSX’s tracks in Northeast Township, Erie County (“the Township”), be reassigned from it to the Township. The parties participating in this proceeding are CSX, the Township, Erie County, and the Pennsylvania Department of Transportation.

On July 21, 2025, a status conference was held in this matter with CSX, the Township, and Erie County participating. During the conference, CSX expressed an intent to abolish the crossing at issue. Therefore, I directed CSX to amend their Petition to include this change in relief.

On October 1, 2025, CSX filed a Petition to Convert Proceeding to an Application for the Abolition of the Bort Road Crossing, wherein CSX requested that this proceeding be converted to an Application Proceeding for the Abolition of the Bort Road Crossing and that a litigation schedule for updated direct and rebuttal testimony and a hearing date be set.
