- 4.) Even in the event of your being the only driver, you must provide answers to Question #5 from the *Verified Statement* portion of our application. The responses to questions 5(a), 5(b), 5(c), 5(d) and 5(e) of the verified statements are insufficient. Title 52 Pa. Code § 29 provides detailed requirements. 

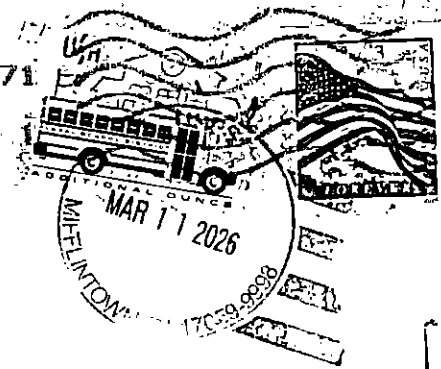
