Following informal discussions with representatives from the Pennsylvania Office of Consumer Advocate ("OCA"), the Borough of Ambler (the "Borough") hereby affirms and clarifies that the Petition to Withdraw the Long-Term Infrastructure Improvement Plan ("LTIIIP") does not modify the Borough's Petition for Approval of its Lead Service Line Replacement Program ("LSLR"), except as specifically set forth in the Petition to Withdraw. The LSLR will remain before the Commission for disposition regardless of the Commission's outcome of this Petition. Additionally, the Borough will continue providing annual unaccounted for water and main break updates to the OCA, Office of Small Business Advocate, and Bureau of Investigation and Enforcement.
