Note: Due to the anticipated overlapping of issues and parties, a Prehearing Conference is being scheduled in this matter contemporaneously with the May 6, 2026 Prehearing Conference scheduled for the *Application of NextEra Energy Transmission MidAtlantic, Inc., filed pursuant to 52 Pa. Code Chapter 57 Subchapter G, for approval to site and construct a 500 kV transmission line associated with the MidAtlantic Resiliency Link Project located in portions of Greene County and Fayette County, Pennsylvania* filed at Docket No. A-2026-3060856.
