

## NOTICE OF COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified, and the original **mailed to**:

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a civil penalty, the suspension or revocation of your operating authority or other such remedy.
- C. You may elect not to contest this Complaint by paying the civil penalty requested in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a civil penalty and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the civil penalty requested.

**COMPLAINT**

The Pennsylvania Public Utility Commission (“Commission” or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement-Motor Carrier Division hereby represents as follows:

1. That CAPITAL CITY CAB SERVICE INC, Respondent, maintains its principal place of business at 362 South Front Street, Steelton, PA 17113.
2. That Respondent was issued a certificate of public convenience on October 26, 1997, by this Commission for taxi authority, at Application Docket No. A-00113875, PUC Utility Code 631532.
3. That on March 6, 2025, PUC Motor Carrier Enforcement Officer Travis Griffith conducted a random inspection near the intersection of Aberdeen Street and Market Street, Harrisburg, Dauphin County, of a 2019 Ford van, bearing PA registration number TX51921 and having vehicle identification numbers ending in the last 4 digits 2367 operated by driver Rachid Hafsi. At the time of the inspection, the following violations were found:
  - a. Taxi failed to display Respondent’s name and associated PUC certificate of convenience number, violating 52 Pa. Code §29.71(a). The penalty for this violation is \$50.
  - b. Taxi failed to have a dome light attached to the roof of the vehicle, as the dome light was on the vehicle’s dashboard, violating 52 Pa. Code §29.314(d). The penalty for this violation is \$100.
  - c. Taxi failed to have a meter installed, violating 52 Pa. Code §29.314(b)(1). The penalty for this violation is \$1,000.
  - d. The wheel nut/bolt for the front, driver’s side tire was missing , violating 52 Pa.Code §29.402(1); 67 Pa. Code §§175.65(a), 175.80(e)(1)(xi). The penalty for this violation is \$100.
  - e. Taxi failed to display the rate of fare, violating 52 Pa. Code §29.316(a)(1)(i). The penalty for this violation is \$50.
  - f. Taxi failed to display the consumer information decal, violating 52 Pa. Code §29.318. The penalty for this violation is \$50.

**WHEREFORE**, the Bureau of Investigation and Enforcement hereby requests that the Commission impose a civil penalty of one thousand three hundred fifty dollars (\$1,350.00) upon CAPITAL CITY CAB SERVICE INC, for the violations described in this Complaint and order such other remedy as the Commission may deem to be appropriate. If payment of the civil penalty is not made, the Bureau of Investigation and Enforcement requests that the Bureau of Administration, Financial & Assessments Office, be directed to refer the matter to the Pennsylvania Office of Attorney General for collection of the civil penalty.
