

- 4a. Denied. PPL denies any incorrect charges on Complainant's current bill.
- 4b. Admitted in part, denied in part. Admitted that on or about June 2, 2009,

Complainant was re-billed following Respondent's discovery and determination of a mixed meter. Upon confirmation that Complainant was being billed for another individual's usage, due to a meter mix, Respondent re-billed Complainant based upon her actual usage. Such re-billing resulted in an additional bill of \$1445.42, for which Respondent offered Complainant a special payment arrangement. Denied that PPL improperly re-billed Complainant. All other allegations are denied.

5. Paragraph 5 constitutes a request for relief to which no Answer is required. To the extent a response is required, PPL incorporates by reference herein the averments set forth in its Answer to Paragraph 4 of the Complaint.


6. No response of answering Respondent is required as the allegations of this paragraph do not pertain to answering Respondent.


