INTERIM ORDER

This Interim Order directs a Prehearing Conference to be scheduled for Monday, April 27, 2026, at 10:00 AM at which time all parties shall be prepared to discuss all outstanding issues and their position on all filings made to date.

HISTORY OF PROCEEDING

On November 18, 2025, Silvia Gracia (Ms. Gracia or Complainant) filed a Formal Complaint (Complaint) with the Pennsylvania Public Utility Commission (Commission) averring that she did not give Clearview Electric, Inc. (Clearview) permission to be her electric generation supplier and that she could not afford her October and November 2025 electric bills issued by PPL Electric Utilities Corporation (PPL Electric).

On December 12, 2025, the Secretary’s Bureau served the Complaint on Clearview.

On January 5, 2026, Respondent filed an untimely¹ Answer and New Matter.

¹ Clearview’s Answer was due to be filed on January 2, 2026. *See* 52 Pa. Code §§ 1.12, 5.61.

Also on January 5, 2026, Respondent filed a Motion to Join PPL Electric and Power Target, LLC (Power Target) as Indispensable Parties.

On February 9, 2026, the Commission issued a Motion Judge Assignment Notice that alerted the parties that I was assigned as the Presiding Officer responsible to resolve any issues which may arise during the preliminary phase of this proceeding.

On February 20, 2026, I issued an Interim Order that granted Clearview's Motion to Join PPL Electric & Power Target as Indispensable Parties.

On February 26, 2026, the Secretary's Bureau e-Served the Complaint on PPL Electric and Power Target.

On March 18, 2026, PPL Electric filed an Answer to the Complaint. Also on March 18, 2026, PPL Electric filed a Preliminary Objection to the Complaint. PPL argued the Complaint is legally insufficient as to PPL Electric, because Complainant failed to allege any unlawful conduct of PPL Electric. A Notice to Plead properly accompanied the Preliminary Objection.

No responsive pleading to the Preliminary Objection was filed.

On March 19, 2026, PPL Electric filed a Motion for Leave to File Answer in Opposition to Clearview Electric's Motion *Nunc Pro Tunc* (Motion for Leave). A Notice to Plead properly accompanied the Motion for Leave.

Also on March 19, 2026, PPL Electric filed an Answer in Opposition to Clearview Electric, Inc.'s Motion to Join PPL Electric and Power Target as Indispensable Parties.

To timely identify the issues and resolve such issues, a Prehearing Conference is necessary. Accordingly, this matter shall proceed to a Prehearing Conference, as scheduled on Monday, April 27, 2026, at 10:00 AM.

ORDER

THEREFORE,

IT IS ORDERED:

1. That this matter shall proceed to a Prehearing Conference, as scheduled on Monday, April 27, 2026, at 10:00 AM.
2. That all parties are directed to attend the Prehearing Conference and be prepared to discuss all outstanding issues and their position on all filings made to date in this matter.
3. Parties are excused from filing Prehearing Memoranda prior to the scheduled Prehearing Conference.
