The purpose of this filing is to implement the following changes:

1. Increase Business Off-Net Local Exchange Service (1-year, 2-year, 3-year and 5-year terms) monthly rates to \$115.00 for Region 1, Zones 1-4 Unlimited Option and for Region 2 Unlimited Option.
2. Withdraw Business Off-Net Centrex Service (1-year, 2-year, 3-year and 5-year terms) for Region 1, Zones 1-4 Unlimited Option, Region 2 Unlimited Option and Region 2 Facilities Based Unlimited Option as there are no customers subscribed to this service.

The rate increase is necessary due to the increase in the rates being charged to Fidium by the underlying providers of these resold access lines.
