RULES & REGULATIONS

1. Advance reservations are required and must be made one (1) hour prior to service being rendered. Any reservation made less than one (1) hour to travel time will be charged an additional fee.
2. Rates for mileage are determined by GPS mapping software and will be calculated from the passenger's pick-up (point of origin) to the passenger's drop-off (point of destination).
3. Service is provided on a non-exclusive basis.
4. The rates and charges in this tariff cover transportation only. All Addition Expenses, including tolls, parking/entrance fees, and other out-of-pocket expenses shall be the responsibility of the customer and will be added onto carrier's charges.
5. Trips on the following Holidays are subject to Additional fees as listed in RATES:
 - New Year's Eve and New Year's Day
 - Memorial Day
 - Independence Day
 - Labor Day
 - Thanksgiving Day and Black Friday (Day after Thanksgiving)
 - Christmas Eve and Christmas Day
6. **ONE-WAY AND ROUND TRIPS**

A One-Way trip commences at the passenger pick up point and ends when the passenger safely exits the vehicle at the passenger drop-off point. A Roundtrip commences at the passenger pickup point, transports the passenger to the passenger drop off point and returns the passenger to the passenger pickup point.
7. Deposit: All reservations require a deposit of not more than 20% of the quoted charter price.
 - a. Deposits are subject to forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date the transportation was to depart.
 - b. Deposits are subject to forfeiture of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transportation was to depart.
8. **CONTRACT SERVICES**

Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any

amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

HOURS OF OPERATION:

Weekday business hours are from 8:00 AM to 6:00 PM on Monday through Friday.

Weekend hours are from 12:01 AM Saturday until 7:59 AM Monday.

Off Hours are from 6:00 PM on any weekday until 7:59 AM on the following weekday.

Mileage Rate: In addition to the above base rates, a mileage rate of \$3.00 per mile or fraction thereof applies on all Ambulatory trips, \$4.00 per mile or fraction thereof applies on all Wheelchair trips, and \$5.00 per mile or fraction thereof applies on Stretcher trips, applies in addition to the Base Rate stated above on all loaded miles from the point of pick-up to the final destination.

Waiting Time: Waiting time during which the driver or crew must wait for the passenger at the pick-up point or drop-off point shall be charged at the rate of \$15.00 for each 15 minutes or fraction thereof, in addition to the appropriate prescribed rates set forth above.

Additional Attendant: An extra attendant shall be provided by reservation in those instances where necessary, according to the passenger's needs or condition. A charge of \$100.00 in addition to base rates and any other additional rates will apply to all trips requiring an extra attendant to assist during the transport.

Stair Chair Service Charge: A charge of \$60.00 in addition to Base rates and any other additional rates will apply to all trips that require the use of a stair chair.

Bariatric Service Charge: A charge of \$80.00 in addition to Base rates and any other additional rates will apply to all trips that require the use of special equipment and/or extra staff to safely transport bariatric passengers.
