Dear Secretary Homsher:

On November 14, 2025, Pennsylvania-American Water Company filed Supplement No. 58 to Tariff Water-PA P.U.C. No. 5 and Supplement No. 61 to Tariff Wastewater PA P.U.C. No. 16 requesting an increase in water and wastewater rates with an effective date of January 13, 2026. Such request was suspended by operation of law at Docket Nos. R-2025-3057983 and R-2025-3058051 until August 13, 2026.

Pursuant to 52 Pa. Code § 71.4(c), this letter is to confirm our understanding that because Pennsylvania-American Water Company has filed with the Commission a general rate investigation under 66 Pa. C.S. § 1308 (d), the filing of quarterly financial earnings disclosure reports is not required, for the quarters inclusive, from the date of filing of the utility's general rate increase to the entry date of the Commission's final order.
