MOTION FOR CONTINUANCE

Code § 1.15(b) and Administrative Law Judge (ALJ) Eranda Vero’s February 18, 2026 Prehearing Order. As set forth below, this Motion is unopposed. In support of this motion, Complainant states as follows:

1. Complainant, proceeding *pro se*, initiated this proceeding as an appeal of the Bureau of Consumer Services November 25, 2024, Informal Complaint Decision (BCS Case No. 4109957) by Formal Complaint dated January 14,2026.
2. Complainant has recently retained counsel to represent her in the above-captioned proceeding.
3. On April 1, 2026, Community Legal Services, Inc., filed a Notice of Appearance on behalf of Complainant, serving the same on Respondent Philadelphia Gas Works (PGW).
4. Complainant submits this motion for continuance of the April 7, 2026, hearing in order to permit her counsel to conduct discovery and interview witnesses to prepare for an evidentiary hearing, and in order to engage in settlement discussions.

5. Counsel for PGW has confirmed that PGW has no objection to this request for continuance.


