THIRD Request for Information

The answers you have provided confirm that virtually all of your current services offered do not fall under the jurisdiction of the Pennsylvania Public Utility Commission, and are incidental to the personal care services your company provides to its customers. **A Certificate of Public Convenience for Paratransit cannot be issued for those services.**

In addition to all exempted services, you are planning on utilizing the services of healthcare brokers like Coordinated Transportation Solutions Inc (CTS), Medical Transportation Management Inc (MTM). These contracts do fall under PUC jurisdiction; therefore, we are asking that you submit a Contract Carrier of Passengers Application. **Please file this application as an ANSWER to this data request under the existing docket 2026-3061292.** This will allow us to apply your initial payment of the \$350 application fee to your amended application.

With your application you are required to submit a contract (or at least a letter of intent) for each healthcare broker whom you wish to contract with. You may mention multiple brokers on one application. Any additional contract that you enter in the future requires an additional amendment (new application including the fee).

**YOU MISUNDERSTOOD THE REQUEST. YOU MUST DOWNLOAD, FILL OUT, AND RETURN THE CONTRACT CARRIER OF PASSENGERS APPLICATION FROM THE PUC WEBSITE TO SUBSTITUTE FOR YOUR CURRENT PARATRANSIT APPLICATION. THE APPLICATION MUST BE FILLED OUT ENTIRELY AND SUBMITTED.**
