STATUS REPORT

By Interim Order Directing the Parties to Submit a Status Report dated March 3, 2026, the Pennsylvania Public Utility Commission Administrative Law Judge, the Honorable Emily I. DeVoe, directed the parties to file a status report regarding the status of the matter at the Court of Common Pleas of Westmoreland County and whether the parties believe the matter before the Commission at Docket No. C-2020-3021730 should remain stayed or whether it should be closed and whether the parties would prefer the tribunal hold a status conference.
