
In accordance with the Order Granting Complainant's Continuance Request and Directing Partis to Provide Available Hearing Dates issued on March 24, 2026 in the above-referenced matter, this letter serves as the joint status report of Dorene Dougherty ("Complainant") and FirstEnergy Pennsylvania Electric Company ("FE PA" or "Company") (collectively, the "Parties"). The March 24, 2026 Order required the Parties to discuss available hearing dates.

Counsel for the Company and the Complainant discussed potential hearing dates between the period of June 2026 and August 2026. The Parties have conferred and are available to provide testimony in this proceeding in the month of August 2026. However, the Parties are not available for a hearing on the following dates in August: 20, 21, and 29.

Additionally, witness availability for the Parties is currently pending and an additional ten (10) days is requested to confirm availability. 
